APPROVED with the Order № 193 dated 17<sup>th</sup> of September 2021

Terms of application of the basic and other rates for the freight-forwarding services for arranging international transportation of containers via Vladivostok port

with delivery from Vladivostok port by railway

#### and the rates for additional services

- 1. The rates are valid for the cargoes delivered from the foreign ports to Vladivostok port and delivered afterwards to the station of destination by rail.
  - 2. Services included into the rates:
- 2.1. The rates mentioned on terms **FI Port of loading FOR Station of destination**, include ocean freight, discharging from the vessel in port Vladivostok, port forwarding, rail freight and providing container (for transportation in FESCO containers). The rates mentioned on terms **FI Port of loading FOT City of destination** also include acceptance of container at the station of destination, delivery of container from the railway station to the consignee's warehouse.
- 2.2. The rates mentioned on terms **CY Vladivostok FOR Station of destination**, include port forwarding, rail freight, providing container (for transportation in FESCO containers). The rates mentioned on terms **CY Vladivostok FOT City of destination** also include acceptance of container at the station of destination, delivery of container from the railway station to the consignee's warehouse.
- 2.3. The rates mentioned on terms **FOR Vladivostok FOR Station of destination**, include VMTP documentation fee, platform positioning, loading of container onto a platform, transportation by rail, providing container (for transportation in FESCO containers). The rates mentioned on terms **CY Vladivostok FOT City of destination** also include acceptance of container at the station of destination, delivery of container from the railway station to the consignee's warehouse.
- 2.4. The rates for SOC do not include liner charges (DTHC, drop-off fee, agency fee, demurrage etc.). In case these charges are paid by the Forwarder the additional documentation fee of RUR 6000 (subject to VAT 0%) is charged. Possibility of collecting of the charges of other carriers by the Forwarder and its amount are agreed with the Forwarder additionally. Possible extra storage charges that may arise due to having no preliminary information of such containers' arrival and to necessary coordination procedures of payment of these charges via the Forwarder, are on the Client's account.
- 3. The rates are valid for transportation of general cargo and are not applicable to transportation of hazardous cargo, cargo that require special temperature maintenance (perishable goods), cargoes in flexi-tank containers and tank containers.
- 4. The rates are valid for the cargo that passes customs clearance by means and at the expense of the Client.

The rates for the cargo that passes customs clearance at the station of destination are subject to charges for arranging transit declaration of the cargoes under customs transit procedure. In case this procedure is arranged by the Forwarder the fee for arranging transit declaration may be applied to the rates at the amount of RUR 3390 per container (subject to VAT 0%). In case transportation is arranged by two or more bills of lading then the fee for arranging the additional transit declaration is charged at the amount of RUR 2323 (subject to VAT 0%) per each additional declaration.

- 5. The rates may be reconsidered in case of the increase/implementation of the charges at the moment of the cargo acceptance for transportation. Rates are valid subject to availability of containers at port of loading.
  - 6. The weight of one cargo package (item) in container should not exceed 1.500 kgs.
- 7. Container gross-weight (which is calculated as the sum of the cargo weight and container weight) should not exceed the conventional container weight mentioned on the CSC plate. At the same time the gross-weight of containers which are dispatched by rail should not exceed 30'480 kgs.

### 8. Charges in port of loading which are not included into the rates:

- 8.1. If the cargo is dispatched from several shippers then consolidation fee in Chinese ports of loading USD 80 (without VAT) per 20/40-feet container is charged.
- 8.2. The fees at the port of loading (including OTHC, documentation fee, demurrage/detention fees, bill of lading correction fee, booking cancellation fee, etc.) are charged from the shipper additionally by fact.
- 8.3. The fee for priority dispatch of containers from port of loading (including release of containers and loading on board a vessel) may be added to the rates.
- 8.4. In case the shipper/client cancels booking within seven calendar days or less prior to Estimated Time of Departure, the fee of CNY 1000 (without VAT) will be charged per 20/40-feet container.

# 9. Charges concerned with arranging port forwarding in Vladivostok and with transportation by rail that are not included into the rates:

- 9.1. In case of making corrections in the order for transportation after start of the service rendering process (which corresponds to the loading onboard date for transportation on terms FI Port of loading FOR Station of destination, to the date of container positioning onto the CY for transportation on terms CY Vladivostok FOR Station of destination, to the date of loading onto the platform for transportation on terms FOR Vladivostok FOR Station of destination) the documentation fee of RUR 3500 per 20/40-feet container (subject to VAT 0%) is charged. The fee is charged for making correction of the following information in the order: the name of shipper/consignee, port of discharge, station or point of destination, customs clearance point, data for the "Special remarks" box of the railway bill, information about the cargo (weight, quantity of packages, name and cargo description which should correspond with the HS code of the cargo which is planned to be used for customs clearance of the cargo in Russian customs).
- 9.2. Expenses for reloading from container to the transport, from container to the warehouse, from container to container and vice versa, cargo lashing/unlashing in container, except special lashing (subject to VAT 0%):

with possible unloading of upto 10% of the cargo from container:

RUR 12500/14500 per 20/40-feet container for the cargo on pallets and in big bags;

RUR 16500/18000 per 20/40-feet container for the non-palletized cargo.

with possible unloading of upto 50% of the cargo from container:

RUR 20500/22000 per 20/40-feet container for the cargo on pallets and in big bags:

RUR 25000/30000 per 20/40-feet container for the non-palletized cargo.

with possible unloading of upto 100% of the cargo from container:

RUR 32500/35000 per 20/40-feet container for the cargo on pallets and in big bags;

RUR 41000/44000 per 20/40-feet container for the non-palletized cargo.

In case of partial unloading of the cargo from container in Vladivostok port, FIT through bill of lading is cancelled, and the transportation cost may be revised.

- 9.3. Possibility of transportation of cars and loaders is to be checked additionally.
- 9.4. The rates include the below mentioned period of storage on a terminal at Vladivostok starting from the day of laden container discharge from the vessel, that is required to arrange custom formalities and railway dispatch formalities under normal circumstances, but subject to proper shipping documentation (commercial invoice, packing list which data correspond with that in a relevant bill of lading) provided by the Client's side (shipper or consignee) not later than the vessel arrival in Vladivostok. However, in case the Client within the below mentioned period, which is enough for arranging of dispatch by rail:
- does not provide correct shipping documents, e.g.: commercial invoice, packing list, which data correspond with B/L or the information of the correct cargo name and its HS code (for the cargo which passes customs clearance in Vladivostok);
  - does not arrange payment for the freight-forwarding services;
  - does not surrender the original Bill of lading or there is no confirmation for a telex release;
  - does not provide details of a consignee, which are compulsory for a railway bill;

the Client is to reimburse the following storage charges till the day documents are accepted by the terminal for dispatch by rail (subject to 0% VAT):

a) for containers with **non-hazardous** cargo dispatched by railway from 25<sup>th</sup> of September (by the date of unloading from the vessel by the VMTP information system):

- in import shipment of containers starting from 10<sup>th</sup> day of container stay on the terminal in Vladivostok:

from 10<sup>th</sup> till 20<sup>th</sup> day – RUR 2400/4200 per 20/40-feet container per day;

over 20 days - RUR 4800/9000 per 20/40-feet container per day.

- in transit to CIS, Mongolia and Europe starting from 15<sup>th</sup> day of container stay on the terminal in Vladivostok:

from 15<sup>th</sup> till 20<sup>th</sup> day – RUR 2400/4200 per 20/40-feet container per day;

over 20 days – RUR 4800/9000 per 20/40-feet container per day.

b) for containers with hazardous cargo:

- in import shipment starting from 5<sup>th</sup> day of container stay on the terminal in Vladivostok:

from 5<sup>th</sup> till 9<sup>th</sup> day – RUR 5500/6500 per 20/40-feet container per day;

from 10<sup>th</sup> till 15<sup>th</sup> day – RUR 6500/7500 per 20/40-feet container per day;

over 15 days - RUR 8500/9000 per 20/40-feet container per day.

<u>- in transit to CIS, Mongolia and Europe</u> starting from 15<sup>th</sup> day of container stay on the terminal in Vladivostok:

15<sup>th</sup> day – RUR 6500/7500 per 20/40-feet container per day;

over 15 days - RUR 8500/9000 per 20/40-feet container per day.

Storage charges are not valid for non-standard, deformed containers, containers with oversized cargo, exceeding the maximum permissible weight of 33 gross tons, flat-rack containers.

9.5. In case of transportation of the cargo that requires lashing or approval of its dispatch by rail, including transportation of IMO cargo or cargo packages which weight exceeds 1.500 kgs, it is necessary to arrange placing and lashing the cargo in a container in accordance with the requirements of Chapter 12 of the Technical Conditions. If the loading of the exact cargo is not covered with this Chapter then execution and approval of the Unspecified Technical Conditions (UTC) and placement of cargo in a container according to UTC is required. In such case the rates are subject to the fee for execution and approval of UTC in the amount which is advised additionally. Such cargo may be accepted for transportation only upon providing photos of the cargo placement in a container.

The shipper must arrange lashing of the cargo in a container at port of loading in accordance with UTC. If it is possible to arrange lashing of IMO cargo in Vladivostok then the rate for bringing the cargo in a container into transportable state (for placing and lashing the cargo in a container using fastening and separation materials) in accordance with the UTC for its further transportation by rail makes RUR 50000/55000 per 20/40-feet container (subject to VAT 0%).

Herewith the Forwarder is not liable to the Client for the impossibility to arrange lashing of IMO cargo in port for its further dispatch by rail. If lashing of IMO cargo in port is not possible, the Forwarder reserves the right to unilaterally refuse to fulfill his obligations in case of detection of deficiencies that cannot be eliminated by available means and endanger people involved in its handling. In this case, the Client is obliged to ensure the export of dangerous cargo from the port area as soon as possible.

In case of transportation of IMO cargo belonging to 1-9 IMO class the rates are subject to additional fee of RUR 6000 per 20/40-feet container (subject to VAT 0%).

The rates are subject to the storage charges indicated till a day of completing of the procedures concerned with the cargo lashing or receiving the approval for it dispatch by rail from Vladivostok as well as expenses concerned with the customs inspection of such containers.

- 9.6. The rates are subject to following fees concerned with possible customs procedures, which should be done by the custom's request:
- a) RUR 5500/8200 per 20/40-feet container is paid for the container movement services for arranging customs procedures, taking samples, fumigation, veterinary and other control and other procedures at the port terminal without unloading of the cargo from container (subject to VAT 0%);
- b) RUR 7000/10000 per 20/40-feet container is paid for the container movement services for arranging customs procedures, taking samples, fumigation, veterinary and other control and other procedures at the port terminal in case of unloading of upto 10% cargo from container (subject to VAT 0%);
- c) RUR 12000/16000 per 20/40-feet container is paid for the container movement services for arranging customs procedures, taking samples, fumigation, veterinary and other control and other procedures at the port terminal in case of unloading of upto 50% cargo from container (subject to VAT 0%);

- d) RUR 15000/19000 per 20/40-feet container is paid for the container movement services for arranging customs procedures, taking samples, fumigation, veterinary and other control and other procedures at the port terminal in case of unloading of upto 100% cargo from container (subject to VAT 0%);
- e) RUR 25000/35000 per 20/40-feet container is paid for the container movement services for arranging customs procedures, taking samples, fumigation, veterinary and other control and other procedures at the port terminal in case the procedures are carried out more than 4 days, regardless of the unloading % (subject to VAT 0%);
- f) in case if container re-stuffing required the actual charges will be applied in addition to the point "a" in accordance with the subcontractors' invoices;
- g) RUR 10370 per 20/40-feet container is paid for the container movement services for arranging X-ray inspection (subject to VAT 0%);
- h) RUR 6500 per 20/40-feet container is paid for container weighting services (displacement of the cargo in container for arranging weighting using vehicles is paid additionally by fact of the arranged works) (subject to VAT 0%).
- 9.7. If necessary the following charges concerned with container marking (labeling) and sealing are charged:
- a) RUR 1228 is paid for the sealing services of the 20/40-feet container, including providing the seal (subject to VAT 0%); RUR 616 is paid for the sealing services of the 20/40-feet container, without providing the seal (subject to VAT 0%);
  - b) RUR 1023 is paid for the labeling services of the 20/40-feet container (subject to VAT 0%);
- c) RUR 850 is paid for providing IMO labels (per each set of labels that is issued for each IMO cargo in container) (subject to VAT 0%).
- 9.8. In case of expiration of the maximum container storage period (120 days from the date when container is unloaded from the vessel), the Forwarder has the right to issue an interim invoice for storage of cargo (for each expired calendar month).
- 9.9. The following fees for organization of customs maintenance of goods services in Vladivostok port can be applied to the tariffs (subject to VAT 0%) if necessary:
- a) RUR 1500 per 20/40-feet container are to be paid for organization of removal of marks of the sanitary and quarantine inspection (SQI) services, documentary control and for receiving the mark "SQC is necessary" at special customs procedures department on the B/L after the arrival of the vessel;
- b) RUR 3000 per 20/40-feet container are to be paid for organization of passing of phytosanitary/veterinary cargo inspection services;

c) are to be paid for presence of a representative during organization of customs inspection/examination services:

- d) RUR 2000 per 20/40-feet container are to be paid for presence of a representative when organizing customs supervision during other operations with the cargo under customs control (except for customs inspection/examination);
- e) RUR 5000 per 20/40-feet container are to be paid for presence of a representative when organizing customs inspection, taking samples of the phyto-sanitary cargo with research at FGBI "VNIIKR":

f) the following fees are to be paid for the services of organizing the taking samples are paid:

- 9.10. In case the preliminary information is not arranged or is arranged incorrectly, the fee of RUR 2729 per 20/40-feet container for additional container sorting service (subject to VAT 0%) is charged. The fee includes sorting operations within the terminal.
- 9.11. Transportation of IMO cargo in containers may require separation of the cargo and implementation of the isolating shield between the cargo and the door. In case separation and/or isolating shield is absent the rates may be subject to the container movement services charge mentioned in point 9.12; the cost of making a wooden isolating shield in the doorway of the container is RUR 10600 per 20/40-feet container (subject to VAT 0%).

the separation material and works are determined additionally by fact.

- 9.12. RUR 5460/8190 per 20/40-feet container is paid for the container movement services for arranging customs for carrying out additional works (including services for placing from a stack, placing on an intra-warehouse transport, moving a container within the boundaries of the seaport to the work area, returning to a stack) (subject to VAT 0%).
- 9.13. The rates are subject to any other incremental/emergency surcharges that may be applicable at time of shipment.
- 9.14. The rates include the following free from demurrage charges in port Vladivostok being calculated from the moment of containers' discharge from the vessel till passing documents to the terminal for dispatch by rail:
- 21 days in case of transportation on terms FI Port of loading FOR Station of destination / FOT City of destination or CY Vladivostok FOR Station of destination / FOT City of destination.
- 12 days in case of transportation on terms FOR Vladivostok FOR Station of destination / FOT City of destination.

The day is counted as a period of time from 0 to 23:59 hours of the local time, herewith the incomplete day is considered as complete. Upon expiration of this period the Client should pay the following fees for each day of container extra demurrage (till the moment the documents are passed for dispatch) in accordance with the Forwarder's/Forwarder's Agent invoice (subject to VAT 0%):

from 1st till 10th day – USD 10/15 per 20'/40' container per day;

over 10 days - USD 15/25 per 20'/40' container per day.

9.15. The rates include 10 days of container free from detention charges calculated from the moment of laden container arrival at the railway station of destination. The day is counted as a period of time from 0 to 23:59 hours of the local time, herewith the incomplete day is considered as complete. Upon expiration of this period the Client should pay the following fees for each day of container extra detention (including the day of returning empty cleaned container to the Forwarder's Agent) (subject to VAT 0%):

from 1st till 10th day – USD 15/20 per 20'/40' container per day;

over 10 days – USD 20/30 per 20'/40' container per day.

9.16. The freight-forwarding services (FFS) for arranging international cargo transportation may include the expenses for arranging convoy of the cargo. Convoy fee will be charged if cargo is subject to convoy.

The rates are not valid for transportation of the cargo which is subject to fortified convoy (including automobiles and its parts, tobacco-products and cargo shipped by or addressed to the embassies and permanent residences of the foreign countries).

9.17. The rates mentioned on terms CY/FOR Vladivostok do not include DTHC at the amount of USD 250/300 per 20/40-feet container (subject to VAT 0%) for transportation under FOML bill of lading.

- 11.8. The charges concerned with arranging terminal handling and trucking from the station of destination that are not mentioned above, including storage of container, truck detention etc., will be charged additionally by fact.

#### 12. Conversion of the charges from the rate currency to the currency of payment.

12.1. Conversion of the charges stipulated in US dollars into the Russian Rubles:

The Forwarder issues invoice to the Client for the services stipulated in US dollars. The cost of the arranged services stipulated in US dollars is paid in Russian Rubles by the Russian Central Bank exchange rate at the date of the service arrangement.

12.2. Conversion of the charges stipulated in Russian Rubles into the US dollars:

The cost of the services concerned with forwarding in Vladivostok port, with transportation by rail and with arranging terminal handling and trucking which is stipulated in Russian Rubles is calculated into the US Dollars by the exchange rate of the Russian Central Bank at the date of the invoice issue.
